He explained how in the past groups in different parts of the country have been successful in their campaigns for restoring lines that better connect communities and these are acting as blue prints for what is currently being worked on for Northern Devon. He also went into detail about how they are planning on securing further funding from Great Western Railway to carry out studies on how an extension to the Tarka Line services to Bideford would work and the benefits of this.
